This is your opportunity to hear first hand from the Board about new and existing business activities in the Village downtown and DDA efforts to grow our business sector and stop blight.

New Hiree: With DDA approval, the Village Council appointed Ms Mitzi Koors as DDA Executive Director, effective June 24, 2024. Ms Koors brings excellent credentials to the office and we all look forward to her input.

You can meet Ms Koors at the Town Hall meeting on July 25.

Ms Julie Muszynski stepped down as DDA Executive Director in April to become Village Treasurer. Thanks to Ms Muszynski's leadership, the DDA Bylaws and practices are in compliance with the redrafted Michigan Act. She identified historic preservation perks for local owners, sought Strategic Plan development, encouraged training and developer input, and diligently nurtured several businesses that will soon grace our downtown.

§ 97.00 is the Anti-Noise and Public Nuisance Ordinance for the Village of Grass Lake. It covers the items too extensive to list here but it is worth noting that animal noises, construction sounds, and people shouting are covered. View at:

§ 98.00 of the Village ordinances covers fireworks, items of interest this time of year include:

§ 98.04 CONSUMER FIREWORKS.

- (A) Consumer fireworks may be used in the village on the day proceeding, the day of and the day after a national holiday without restriction.
- (B) At any time other than the day proceeding, the day of and/or the day after a national holiday, consumer fireworks may be used in the village subject to the following requirements and restrictions.
- (1) On Sundays through Thursdays, consumer fireworks may be used up to 10 p.m.
- (2) On Fridays and Saturdays, consumer fireworks may be used up to midnight.
- (3) Consumer fireworks shall not be used if a burn ban is in effect.
- (4) A person shall not ignite, discharge or use consumer fireworks on public property, school property, church property or the property of another person without that person or organization's express permission to use the consumer fireworks on those premises.
- (5) A person shall not use consumer fireworks or low-impact fireworks while under the influence of alcoholic liquor, a controlled substance or a combination of alcoholic liquor and a controlled substance.
- (6) Consumer fireworks shall only be used in accordance with all applicable local, state and federal laws.
